Standard Online Auction Rules

#### **RULES:**



- By registering, you agree to all terms and conditions of the auction.

All bidders use the allocated Google forms for placing bids.

#### 2. Bidding Process

- All bids are binding and cannot be withdrawn.
- Bids must be made in the specified bid increments.
- The highest bid at the time of auction closing will be considered the winning bid, subject to meeting the reserve price.

#### 3. Reserve Price

- The items have a reserve price (minimum selling / bids starting price).
- If you place a bid, you must be prepared to pay that amount.

- Should a bid be below the reserve price and the auction closes, the person with the highest bid will have the first option to buy at the reserve price.
- If the reserve price is not met, the item will not be sold unless otherwise agreed.

#### 4. Auction Closing

- Friday, 11 July 2025 at 12:00
- The auctioneer or platform may extend bidding, for at least 2 minutes, if last-minute bids are received (optional rule known as "anti-sniping").

#### 5. Payment

- Payment must be made within 24–48 hours after the auction closes into the account of NG Koedoeskop (Koedoeskop Gemeenskapskerk).
- Accepted payment methods will be communicated with the person/s whom the bid is awarded to.
- No item will be shipped or released before full payment is received.

#### 6. Collection & Shipping

- Buyers are responsible for collecting their items or covering courier costs within 7 (seven)
  working days from Koedoeskop Gemeenskapskerk (Community Church). No item will be
  released or shipped without full payment.
- Shipping/courier costs are the buyer's responsibility.
- No item will be handed over without proof of payment.

#### 7. Item Descriptions

- All items are sold "as is," (voetstoots) with no guarantees unless clearly stated.
- Every effort is made to provide accurate descriptions, but it is the buyer's responsibility to inspect or inquire about an item before bidding.

#### 8. Disputes

- In the event of a dispute, the decision of the auctioneer (Koedoeskop Gemeenskapskerk) or platform administrator is final.
